NFP Exhibitor Agreement

As a Not For Profit site, it is expected that you adhere to the following immediate guidelines in addition to those set out in the attached Guidelines herein:

- No products are to be sold, unless special arrangements have been made with organisers;
- Should power be necessary for your stand, there is a cost of \$50; and
- In the event that you (the Not For Profit Exhibitor) cancels within sixty (60) days of the event, you will be held liable for payment of the equivalent amount of the stand.

2024 NOT-FOR-PROFIT APPLICATION & GUIDELINES

1. To assist the organisers with advertising of the events, we invite you to supply the name and profile of a community member who has a high quality product or service who would benefit from promoting their product/s or goods for the craft industry.
2. You must provide CraftAlive organisers with evidence of your organisation's registration as a non-profit organisation or community interest group.
3. You must provide CraftAlive organisers with proof of Public Liability Insurance.
4. As a non-profit organisation, you must be demonstrating your services or products on your site at all times during the event.
5. Your stall must be manned at all times during the event.
6. Your stand must have professional signage; (as determined by the organiser) and be engaging for the public to enquire about your services.
7. If you are planning a raffle or community fundraiser as part of your site, the full details of the raffle must be forwarded to the CraftAlive organisers **one month** before the event. Details to include organiser name, phone number, evidence of permission to hold a raffle or fundraiser, prizes information, potential income to be generated via the raffle and how the funds will be distributed.
8. All sites will be allocated to non-profit organisations at the discretion of the CraftAlive organisers; however, you may request your preference for the site size and location.
9. A Site Fee and Site Size schedule will be issued upon request.
10. CraftAlive reserves the right to accept or reject a not for profit application and shall not be required to provide any reasons for such refusal and is deemed to be the sole arbiter in any decisions made in this respect. When accepted by the Organiser, the application becomes a binding contract between the applicant and the Organiser. The applicant is then known as the Exhibitor and agrees to exhibit and be bound by these conditions of exhibiting, the rules and regulations, and Terms and Conditions outlined in the CraftAlive Exhibitor Information Pack.
